Payment & Cancellation

If payment is to be made by cheque then this must accompany the booking form and be made payable to LionHeart 2008 Ltd, drawn on a UK clearing bank.

If payment is requested on a credit basis then a tax invoice will be issued on receipt of a properly completed booking form. LionHeart's payment terms are 30 days from date of invoice otherwise the booking will be cancelled.

If a booking is made within one calendar month of the event than payment must be made by cheque and accompany the booking form.

Cancellation can be accepted and monies refunded once the invoice has been paid according to the following conditions:

- Up to 3 months before the event 100% refund.
- Between 2 and 3 months before the event 75% refund.
- Between 1 and 2 months before the event 50% refund.
